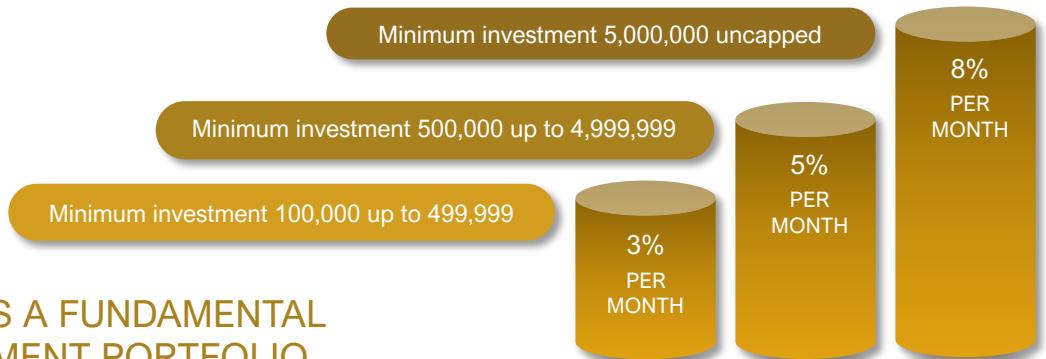
Executive Overview

PROCEDURE

A simple PROCEDURE ensures your swift investment into **GOLD**, viz. :

- You sign a legally binding Contract detailing the terms and conditions of your investment in Gold, wherein your absolute monthly returns are provided.
- After signing the Contract you are required to transfer your investment capital to the MCG Gold Platform account.
- Upon receipt of your investment capital, MCG will allocate your individual account, which provides you with a monthly statement of account on your investment. This process can take between 3-6 weeks.
- Within 2 weeks from receipt of your investment capital and the setting up of your account, MCG engages your funds into the MCG Gold buy-sell program.
- Every 4 weeks you are paid your returns on your capital. Your monthly returns are paid at the end of each trading month.
- At expiry of the Contract (12 months), you may reinvest for a further 12-month period under a new Contract, or elect to withdraw your investment capital from the program.
